#### Tax Declarations ぜいきん の しんこく

By submitting your tax return, you may be eligible for a reimursement of some of the money you paid in tax.

Who needs to submit a tax declaration?

Anyone that receives a salary but did not complete their year-end tax adjustment

Anyone who has received a salary from more than one company/employer during the year

Anyone who left their place of work and started a new job in the same year

Anyone who did not include information about their dependents in their year-end tax adjustment

What do you need to make a tax declaration?

- · A copy of your residence card or alien registration card
- The original copy of your certificate of income and withholding tax
- A copy of the bank book (*tsuchou*) for the bank account you would like your tax reimbursement to be sent to (the page which shows your name and account number).
- Passport
- Personal seal (inkan)
- $\boldsymbol{\cdot}$  Documentation (including Japanese translation) to prove your dependents
- · Documentation (including Japanese translation) to prove that you are sending money to dependents overseas.
- · Your national health insurance certificate
- · National pension certificate
- · Proof of life insurance fee exemption
- Proof of medical costs for you and your family members, etc



You cannot make your tax declarations at the Ueno Tax Office, Iga Prefectural Tax Office or Iga City Hall.

Municipal certifications and documents are issued upon presentation of your tax return slip.

If those who are required to pay income tax, municipal and prefectural tax do not file their tax returns, they cannot be issued the relevant documents (proof of income, proof of taxes paid) that are needed in order to apply for changes in residency status, child benefit, educational support, public housing etc. They may not be able to access other public services, either

## Ways to Avoid Catching the Flu いんふるえんざ に かからない ために

Eat a well-balanced diet Make sure you get enough sleep

Maintain rooms at 20-25C and a humidity of 50-60%.

Wash your hands thoroughly (use plenty of soap, wash your palms, between fingers and your wrists and rinse with running water) and gargle often.

#### Change in Automobile Tax Amount じどうしゃぜい の がくが へんこうになります

There will be a rise in tax for two-wheeled vehicles, special vehicles (eg farm vehicles etc) and yellow-plate cars from 2016.

There will be a rise in tax for 4 wheel vehicles and 3 wheel

yellow plate vehicles during the fiscal year 2016 (which includes part of 2015). (4 Wheel Vehicles, 3 wheel yellow plate vehicles) The tax rate from the 'New Registrations after 1 April 2015' form below will be applied The Tax amounts listed in the diagram "New Registration after 1 April 2015" below will be applied Only those vehicles which were newly registered on 1 April 2015 will have the amount of tax raised from fiscal year 2015. Vehicles registered after 2 April will follow the tax amounts for fiscal year 2016.

Vehicles that have been registered for more than 13 years will will follow the tax amounts listed in the "Vehicles Registered more than 13 Years Ago" diagram below. However, this does not apply to yellow plate vehicles and test drive cars that run on electricity, methanol, or gasoline/electricity hybrid vehicles.

Yellow plate vehicle road tax is calculated on 1 April every year, and charged to the person who is the registered owner of the vehicle on that date.

If you wish to take your vehicle off the road, change the name or address of the owner etc, you must complete the necessary paperwork to do so.

#### Eligibility for Child Benefit to increase from December 2014 บีชีวิลิมิวิสาสตร์ดายาเลย Eligibility for Child Benefit to increase from December 2014

#### Application Required

Up until now, those receiving a public pension (widowers pension, pension for the disabled, old-age pension, work-related injury pension, compensation to the bereaved etc) were not eligible to receive Child Benefit, but from December 2014, changes in the child Benefit payment law means that those who receive pension payments that are less than what they would receive as child benefit will now also be able to claim the different in amount. N order to receive child benefit payments, you need to apply to the Child and Family Division (kodomo katei ka) in City Hall, or the Residence and Welfare Division (jumin fukushi ka) in any of City Hall's branch offices.

If you are unsure if the payments you currently receive are less than what you would receive through child benefit, please consult with the Child and Family Division. You will be able to receive the benefit payments under the latest amendments if...

Grandparents raising children have a low-amount old-age pension

#### Infant Health Checkups & Development Tests <あかちゃん の けんしん > Kenkou Suishin Ka TEL 0595-22-9653

In Iga, checkup examinations are available at 18 months (children up until 21 months can take it) and 3 years (for children up to 3 years and 9 months of age). Notifications will be sent out to homes with children eligibile for the checkups. These notifications will be in Japanese, so please bring your letter along with you to City Hall if you need help understanding its content.

#### 18 month Checkup (free)

This is a very important period in your child's development of basic functions such as speech, walking and so on, so the 18 month checkup is a general examination. Your child will be observed day by day to assess his or her emotional and physical development. Make use of this free checkup to make sure your child has a healthy upbringing.

#### 3 years (free)

This is the time when a child is becoming aware of his or herself and beginning the important process of independence from their mother. A more detailed evaluation will be carried out, including checks of physical and psychological development, as well as teeth, hearing and vision. Aside from observing your child's development, the 3 year exam is also a chance for families with children to talk with and socialize with one another.

【Examinations】 Urine exam, measuring weight and height, medical checkup, dental checkup, reflex development test, advice on dental health and nutrition.
